<p>Violation #23. Date marking and disposition Observed missing date marking on container of oatmeal in walking refrigerator. Provide date marking. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are RTE and held refrigerated for more than 24 hours, shall be properly date marked unless otherwise exempted.</p>
<p>Violation #39. No Contamination (preparation, storage, display) Observed utensils stored inside both preparation sinks. Remove and store in designated areas. CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.</p>
<p>Violation #55. Facilities installed, maintained, & clean Observed stained ceiling tiles above service lines. Replace, clean and disinfect ceiling tiles. CODE REFERENCE: 64E-11.003(5).
